Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Lee Sansom trading as LJS Event Services and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Lee Sansom trading as LJS Event Services is the "data controller". This means that Lee Sansom trading as LJS Event Services determines the purposes for which, and the manner in which, your Data is processed.

Data collected

Data that is given to us by you

- 7. Lee Sansom trading as LJS Event Services will collect your Data in a number of ways, for example:

 - c. when you make payments to us, through this Website or otherwise;

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:

in each case, in accordance with this privacy policy.

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

Who we share Data with

- 11. We may share your Data with the following groups of people for the following reasons:
 - a. our employees, agents and/or professional advisors to assist with paying invoices, financial matters or design and operation of your event or to give a quotation;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 12. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
 - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

Data retention

Your rights

- 17. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
